Lauri Alpern, MUPP, is a leading sustainability strategist and social venture advisor whose work is based in operations and human capital development. She is principal of Open Door Advisors (ODA), which she started in 2009 to follow her passion – working with social entrepreneurs navigating sustainable income and social impact through innovative business ventures. ODA helps high impact entrepreneurial nonprofits and social ventures expertly plan and manage the triple bottom line of mission, money, and sustainability through strategy and organizational development, business planning, leadership coaching, and investment.

Throughout her career, Lauri has led numerous nonprofit and social enterprise teams through growth and development strategies, which have resulted in new levels of revenue generation, social impact and organizational effectiveness. Here are just a few examples. Recently, Lauri completed a large-scale assessment of mission-based programs and business operations of one of New York's leading social enterprise ventures, Hot Bread Kitchen. The Illinois Community Action Development Corporation (ICADC) commissioned Open Door Advisors to develop a white paper on the need and opportunities for social enterprise programs and services for the Community Action Agency Network throughout Illinois. ICADC is now implementing the recommendations with Lauri's guidance and advice. Lauri served as the lead strategy advisor for the scale and replication of Inspiration Kitchens, the culinary arts and restaurant social enterprise of Chicago-based nonprofit, Inspiration Corporation. The project resulted in the successful development of a 70-seat family family-focused social enterprise restaurant in the Garfield Park neighborhood on Chicago's West side. Inspiration Kitchens operates a catering company and workforce development program in conjunction with the restaurant.

Prior to founding Open Door Advisors, Lauri was a partner in the strategy firm ROI (Return on Inspiration) Ventures, LLC (now known as Frequency 540), where she managed a diverse client portfolio centered on social venture strategy and leadership development for a range of highly innovative organizations.

Lauri also served as executive director of The Enterprising Kitchen (TEK), a nonprofit social enterprise, providing workforce development services to unemployed women through a manufacturing company that produced natural soaps and soap products. Lauri re-energized and refocused TEK's social mission, to more than double the number of lower-income women in the workforce development program. She also led the restructuring of all business operations: sales, marketing, production and manufacturing, which achieved record sales, profitability, philanthropic and public relations goals.

Community collaboration and resource development are key to Lauri's work. She helped found the Great Cities Institute at the University of Illinois at Chicago (UIC), where she served as associate director. There she created new resources and partnerships among faculty, students, community, and corporate partners all seeking to improve the quality of life in Chicago and other cities. Prior to her years at UIC, with a portfolio that centered on urban industrial development, she served as assistant commissioner for the City of Chicago Department of Economic Development in the administrations of Mayors Harold Washington and Eugene Sawyer.

Lauri has a Bachelor's degree from the University of Wisconsin, a Master's degree in Urban Planning with a specialization in Economic Development from the University of Illinois. Lauri is certified in the Lean Six Sigma management practice, which promotes the dual goals of continuous process improvement and respect for people. Lauri is a PhD candidate in Business Psychology at The Chicago School of Professional Psychology. Lauri serves as president of the board of Growing Home, Inc., a nonprofit social enterprise, and Chicago's first urban organic production farm.



Joy Aruguete, MA has served as the Chief Executive Officer of Bickerdike Redevelopment Corporation for the past nineteen years. In this capacity, she supervises operations for this 47-year-old award-winning nonprofit community development corporation dedicated to community controlled development, the preservation and management of affordable housing, economic development centered on job creation, comprehensive community planning and engagement, and the development of community leaders. Joy manages corporate, subsidiary and affiliate business operations of approximately \$40 million annually and oversees the work of 75 staff members who carry out Bickerdike's mission. This work has included: the development of 1,227 housing units, including 154 single family homes, with an additional 123 units under development; resident-involved property management of 1,022 rental and cooperative housing units; management of over 60,000 square ft. of commercial space across seven sites; the performance of minor repairs in over 700 households; the development of hundreds of jobs for community residents; and the development of hundreds of community leaders. Bickerdike is also the lead agency for the Humboldt Park New Communities Program, actively engaging 70 neighborhood organizations and institutions in the successful implementation of over 100 wide ranging community development initiatives.

Joy also oversees the work of Humboldt Construction Company, a 33-year-old wholly-owned subsidiary of Bickerdike. Humboldt Construction Company's central goal is job creation for local residents, with over 100 area residents having been trained and placed into skilled trade union jobs. The company provides general contracting services and quality construction through a team of approximately 20 carpenters who are members of the Carpenters Union Local 13.

For seventeen years, Joy has been an active Board member of the Chicago Rehab Network where she currently serves as board President. In this role she provides citywide leadership in efforts to ensure effective policy, capacity and resources for affordable housing and community development in Chicago.

Joy was appointed to the national Enterprise Community Partners Leadership Council in late 2006, where she actively participates in shaping national community development priorities. She has served on the Federal Home Loan Bank of Chicago's Community Investment Advisory Council since 2009. She was appointed by Mayor Richard Daley to the Board of Directors of the Chicago Community Land Trust in 2006 and reappointed by Mayor Rahm Emanuel in 2012, where she also serves as Chair of the Projects Committee.

In May 2009 joy was presented with the 40 Who've Made A Difference Award by Business and Professional People for the Public Interest. In December 2002 she was presented with the Tom Gobby Award for Neighborhood Leadership by LaSalle Bank.

Joy has been active in the nonprofit sector for over 25 years. Her work at Bickerdike builds upon her background in community organizing and economic development. Her experience is enriched by six years of teaching at the University of Illinois at Chicago in the Urban Developers Program of the College of Urban Planning and Policy Administration. Prior to this, she taught for two years at the University of Wisconsin-Madison. She received her Masters Degree from the University of Wisconsin-Madison., holds holds two Bachelor degrees, a Certificate in Non-Profit Management from Roosevelt University, and an Illinois Real Estate Managing Broker License.

Tony Banout, PhD, is vice president of Institutional Advancement at Interfaith Youth Core (IFYC). He leads IFYC's development program and manages relationships with IFYC's Board of Directors. Tony's decade of experience in nonprofit management and fundraising includes work in the fields of social services, civil rights, and public health. Born to Egyptian parents and raised in New York, Tony received a PhD in Religion from the Divinity School at the University of Chicago for a dissertation treating democracy and religious freedom. Virginia had the life-changing opportunity of participating in the 1995 UN Conference on Women in Beijing and is a frequent speaker on issues affecting Latinos, women and children.
